
# Repreve<sup>®</sup> Process ☐ GreenScreen<sup>®</sup> Revive<sup>™</sup>



Post-industrial fiber waste and post-consumer plastics are collected.

The collected waste then enters a unique material conversion; it is chopped, ground, melted, and reformulated.

Repreve, a recycled chip, is formed.



The Repreve chip is extruded and textured.



Repreve – a family of 100% recycled fibers.



The Repreve fibers are woven to create GreenScreen Revive.
